Background

As globalisation accelerates the growth of international recruitment, the risks that business are contributing to harms to migrant workers increase. It is crucial for business to ensure that workers' rights, including those of migrant workers, are protected to prevent harms and optimize the benefits of international recruitment.

Due diligence is the process for enterprises to identify, prevent, mitigate and account for how they address actual and potential adverse impacts in their own operations and along the supply chain. The Organisation for Economic Co-operation and Development (OECD) has developed practical guidance to help companies implement due diligence to systematically prevent and address risks in global supply chains, which can be applied in this context. The International Organization for Migration (IOM) provides tested services and advice to support companies in addressing adverse impacts concerning migrant workers and contributing to social and economic development.
