### **EVENT OVERVIEW**

The OECD Guidelines for Multinational Enterprises on Responsible Business Conduct are recommendations addressed by governments to multinational enterprises to enhance the business contribution to sustainable development and address adverse impacts associated with business activities on people, planet, and society. The Guidelines were updated in June 2023 to respond to urgent social and environmental priorities facing business and society today.

On 4-5 December 2023, we turn our attention to the MENA region as five leading economies come together to launch a new three-year regional programme on responsible business conduct (RBC), spearheaded by the OECD with the support of the governments of Germany and Switzerland. This will be the first project of its kind and offers a unique opportunity to identify step-changes in government and across companies to ensure responsible business conduct becomes a reality.

The first half-day will include a high-level panel of government representatives, followed by a session to gather stakeholder views from across business, trade unions and civil society. The second day will be framed as a workshop designed to distil priorities to help set the direction of the new programme.
