**The role of NCPs: What is the potential impact of the proposed CSDD Directive on the work of NCPs? What is the relevance of NCPs vis-à-vis implementation of the Directive?**

*The Commission proposes, as part of accompanying measures, that Member States will provide information and support to companies covered by the directive and their business relationships to help them fulfil their obligations (Art. 14). It also proposes that Member States designate a supervisory authority to ensure effective enforcement of the Directive (Art. 17-20), and adapt their rules on civil liability to cover cases where damage results from failure by a company to comply with due diligence obligations (Art. 22). At the European level, the Commission proposes establishing a European Network of Supervisory Authorities that will bring together representatives of the national bodies, in order to ensure a coordinated approach and enable knowledge and experience sharing (Art. 21). This session will explore the role that NCPs can play in supporting the European Commission and EU Member States in this context.*
